The launching of the online application ceremony was officiated by the Director of Yayasan Sabah, Dato' Sri Haji Gulamhaidar @ Yusof bin Khan Bahadar on 3 August 2023 at Arena Futsal, Tun Adnan Sports Complex, Likas.

Bhd., aimed at upgrading the booking system from manual to online and implementing cashless payment through the GoNet application," he explained.
